## Title: Fees for Memorial Services

## 1.0 PURPOSE

To define fees and honoraria payable for memorial services conducted at USNH or at outside facilities.

## 2.0 APPLICABILITY

- 2.1 The right of first refusal for officiating a memorial service goes to the settled minister. If a non-Unitarian Universalist officiant is approved by the settled minister, that person is responsible for ensuring that the memorial service is consistent with UU principles.
- **2.2** For current members, there is no fee for the minister to officiate. This also applies to memorial services for a member's immediate family (spouse/partner, child, parent, sibling). For hardship or other special circumstances, the fees for non-members may be reduced or waived at the discretion of the Minister.
- **2.3** Refer to the revision history to determine the most recent update. Fees may be increased from time to time, requiring changes to maintain the currency of this document.

### 4.0 HONORARIA PAYABLE TO INDIVIDUALS

- **4.1 Minister** For members: free. For non-members: \$400.
- **4.2 Pianist** \$200

### 5.0 SOUND AND TECHNICAL SUPPORT

- 5.1 There is no charge for the use of simple voice amplification in the sanctuary.
- **5.2** If additional assistance is required to play music, make a recording, or set up additional microphones in the sanctuary or in the social hall, the fee is \$150. If the required technician time exceeds 90 minutes, additional fees will be billed at the same rate for each 90 minutes or portion thereof.
